

**SUGGESTED USE:****For Pre-Cardio Workout Performance:**

Mix 1 scoop with 8 – 10 fl. oz. of cold water, or 2 scoops with 16 – 20 fl. oz. of cold water, and take 30 minutes before workout.

**For Weight Loss Support and Pre-Cardio Workout Performance:**

Mix 1 scoop with 8 – 10 fl. oz. of cold water and take 30 minutes before workout, and then take a 2nd scoop 4 hours later.

**For Weight Loss Support:**
