

randomized clinical study of 140 healthy overweight people compared the use of Slimvance® in conjunction with an 1,800-calorie diet and walking plan to a placebo with the same diet and walking plan. * In a randomized, double-blind, placebo-controlled study, 70 men and women took a placebo or AferFIT™ and followed their routine diet and exercise regimen for 12 weeks. Results from an ITT analysis of covariance showed that the increase above pre-treatment in those taking AferFIT™ burned an additional 171 more calories per day (225.5 calories per day vs. 54.32 calories per day) than the placebo group after 12 weeks.
